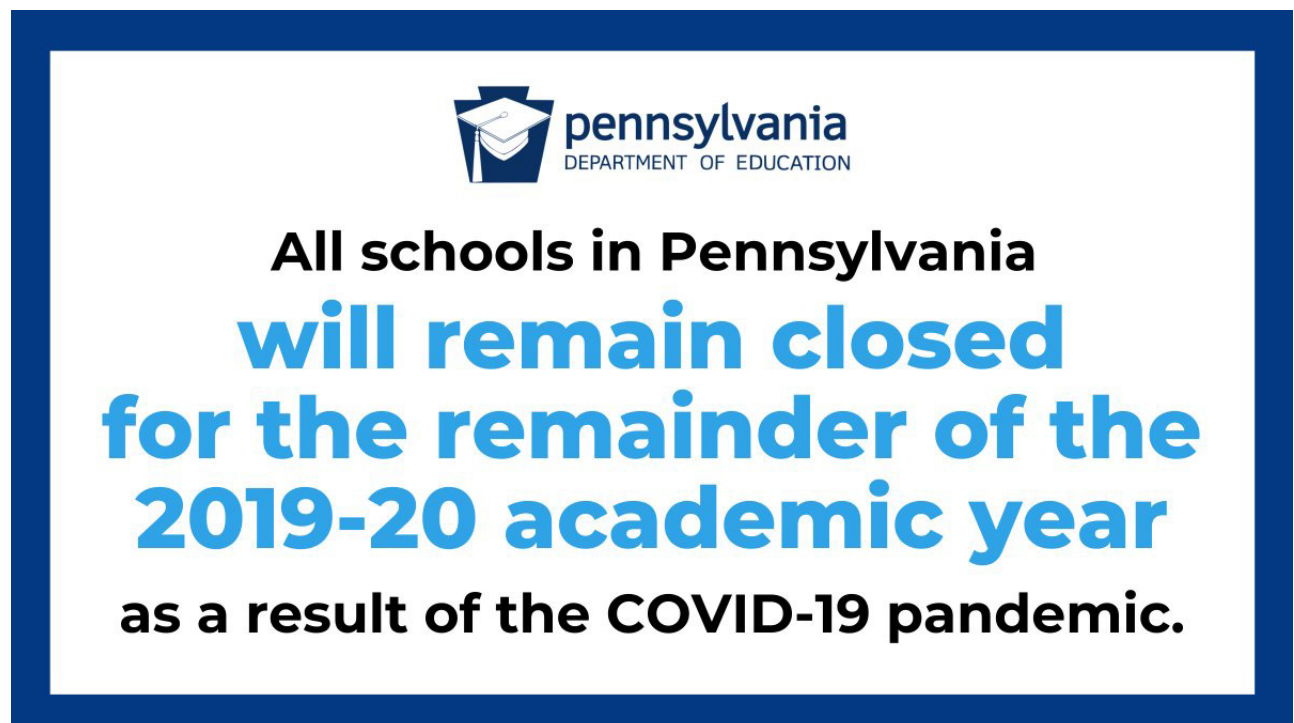
## Message from Senator Kearney

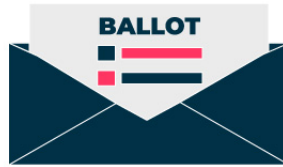

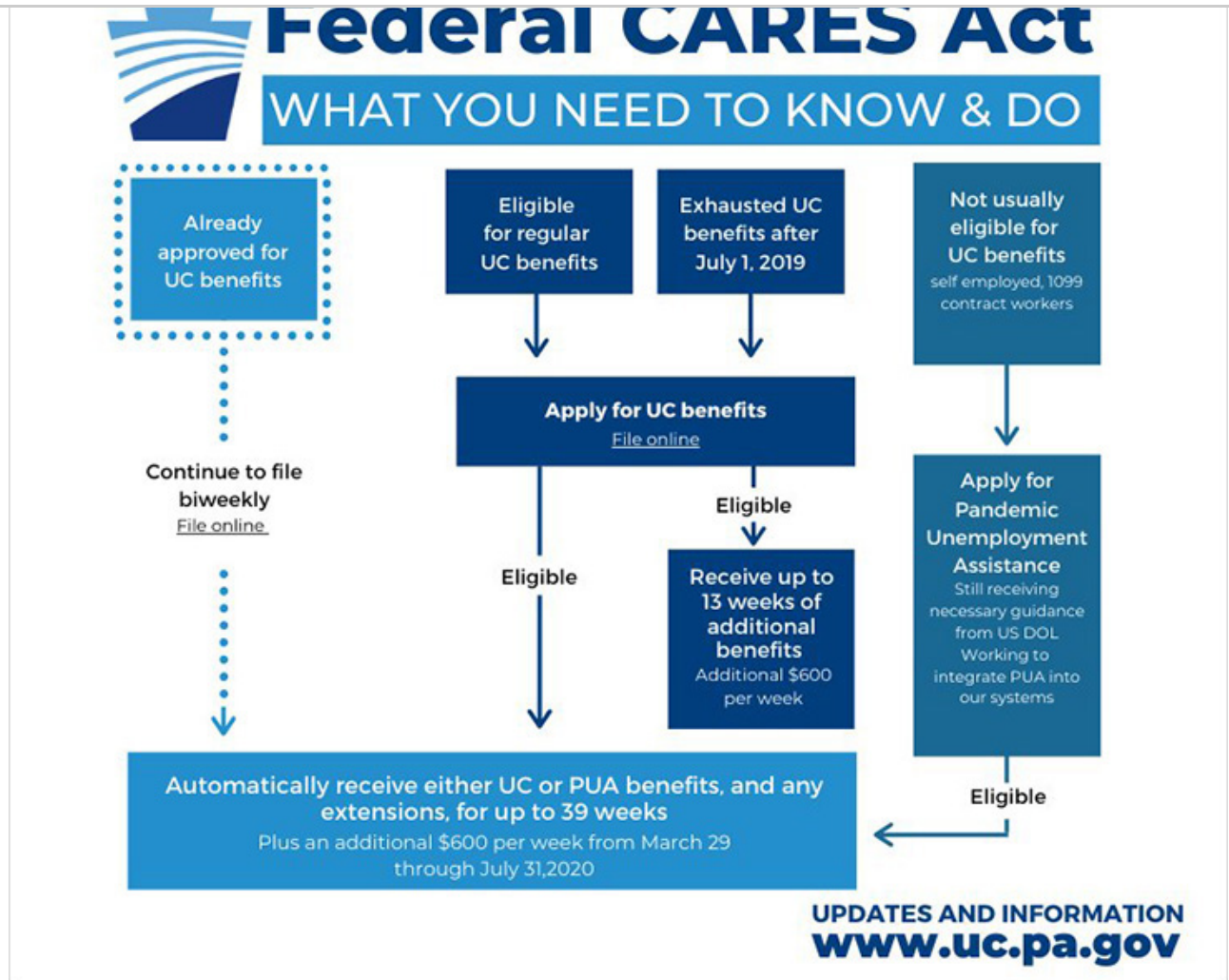
## Job Hiring Portal
