Message from Senator Kearney

The outbreak of COVID-19, or coronavirus, has presented many challenges for all of us. But we are all in this together. Below you will find information and resources to support our families and communities during this time. Stay safe and stay healthy.



Telephone Townhall

On Tuesday, March 17, I hosted a telephone townhall with local officials and health experts to answer your questions on COVID-19. You can listen to the entire townhall <u>here</u>.

Business Closures

On March 16, Governor Wolf recommended all non-essential businesses in Pennsylvania to close to mitigate the spread of COVID-19. In particular, the following types of businesses should temporarily cease regular operations: Community and recreation centers; gyms and exercise facilities; hair salons, nail salons, and spas; casinos, concert venues, and theaters; sporting events facilities and golf courses; and non-essential retail facilities, including shopping malls (except for pharmacy or other healthcare facilities located therein). Below are essential businesses that **SHOULD** stay open.



Governor Wolf also ordered all restaurants and bars to close their dine-in facilities, starting on March 16. Businesses that offer carry-out, delivery, and drive-through service may continue to do so, but eating and drinking inside restaurants and bars is temporarily prohibited.

Housing Assistance

The U.S. Department of Housing and Urban Development is <u>suspending foreclosures and</u> evictions for mortgages insured by the Federal Housing Administration until the end of April 2020.

The Pennsylvania Public Utility Commission (PUC) has issued an emergency order prohibiting electric, natural gas, water, wastewater, telecommunication, and steam utility terminations. This will remain in place for as long as the disaster proclamation of Disaster, signed by Governor Wolf on March 6, is in effect.

Food Assistance for Seniors

Many grocery stores are offering special shopping timeslots for seniors and individuals with compromised immune systems. Please check with your local grocer before heading to the store. Order online if possible.

Delaware County seniors who need a grab-and-go meal can contact Senior Community Services' senior centers. Visit <u>scsdelco.org/centers/centers.shtml</u> for contact information.

Centers are open from 8:30 AM to 2:00 PM.

Food Assistance for Students



Governor Wolf announced all K-12 schools in Pennsylvania will be closed for 10 business days, effective Monday, March 16. Many school districts are offering meals for students in need during this closure.

Great Valley School District

Meals will be available for pick-up from 10 AM - 12 PM, Monday through Thursday, from Monday, March 16 and through Thursday, March 27. Both breakfast and lunch will be distributed at no cost at the Samuel and M. Elizabeth Burke Community Park in Malvern, near St. Pat's Church. Look for the distribution tent. Only one day's meals may be picked up per day.

Interboro School District

From Monday, March 23 through Friday, March 27, the District will make "Grab and Go" breakfast and lunches available for all PreK - 12th grade students between 11:00 AM - 1:00 PM. The District will determine the location(s) of distribution and will send logistical information to parents/guardians by 3:00 PM on Friday, March 20.

Unemployment Compensation

If your job has been affected by COVID-19, you may be eligible to receive unemployment compensation benefits. You can <u>apply online</u> to get started.

Please note that the waiting week has been suspended. Eligible claimants may receive benefits for the first week that they are unemployed. Previously, claimants were not eligible for benefits during their first week of unemployment.

Work search and work registration requirements have been temporarily waived for all claimants. Claimants are not required to prove they have applied or searched for a new job to maintain UC benefits. Claimants are also not required to register with PA Career Link.





Transportation Updates

All Driver License Centers and Photo License Centers in Pennsylvania will be closed for two weeks effective Monday, March 16. All driver licenses, photo ID cards, disability parking placards, vehicle registrations, and vehicle inspections scheduled to expire between March 16 and March 31, 2020 will be extended until April 30, 2020.
